

PRIVACY STATEMENT FOR THE SECURITY REGISTER

(General Data Protection Regulation (EU) 2016/679, articles 12-14)

This privacy statement explains how the Fingrid Group processes personal data guaranteeing company security. Fingrid Group comprises Fingrid Oyj and its subsidiaries Finextra Oy and Fingrid Datahub Oy. Fingrid Oyj deals with questions concerning personal data centrally within the Group, and the execution of the rights of data subjects presented below in this statement.

3. The purpose of and grounds for personal data processing

The processing of personal data is based on the justified benefit of Fingrid or a third party, and personal data is processed in order to ensure physical security, to protect property and to ensure the data security of system operation, access control and access management.

4. Personal data to be processed

- basic data such as name, personal ID, company, telephone number, e-mail
- contact information
- car registration number
- photographic material and video recordings
- information on access passes
- the result a security assessment

5. Regular data sources

Personal data is obtained from the data subject him/herself, through logins and logouts, using surveillance equipment such as video cameras, and from the authorities.

6. Regular assignments of data

Fingrid does not assign personal data regularly to external parties.

Data may be assigned to the authorities or other external parties for the investigation of crimes, misdemeanours or malicious damage.

7. The transfer of data outside the EU or EEA

Data in a register may be transferred outside the area of member states of the European Union or the European Economic Area, if this is necessary in terms of the purposes of processing the above-mentioned personal data or of the technical execution of the data processing. In that case, the transfer of the data complies with the requirements stipulated in the EU Data Protection Regulation.

8. Time for storing data

Personal data is basically processed and stored only during the time it is needed for the purpose of the processing of the personal data.

9. Rights of the data subject

A data subject is entitled to ask the registrar for access to personal data concerning him/herself, and has the right to request the correction of his/her personal data or the limiting of its processing.

A data subject has the right to have his/her personal data deleted, if the data is not needed for purposes as described in Section 3. There is no right to the removal of data if Fingrid has a statutory obligation to keep the data, or if Fingrid needs the data to prepare, present or defend a legal claim.
